

Group Golf

Bergen County Department of Parks

Group golf outings are available for small groups at certain times of the year, weekdays only. A group golf outing must be arranged by a registered Bergen County resident. Non-Bergen County residents may play in the outing.

Schedule: Available June - November. No Holidays or Weekends.

Group Size: Minimum of 1 tee time (four golfers), Maximum of 7 tee times (twenty-eight golfers). Group is responsible to fill each reserved tee time with 4 golfers.

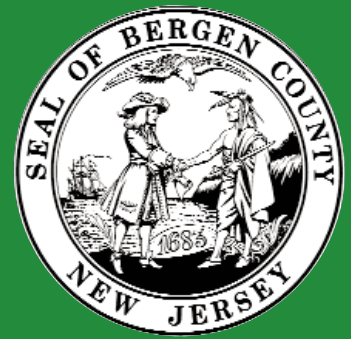
Tee Times: Group Golf may be scheduled to begin no earlier than 11:00 AM. Consecutive tee times will be reserved every 10 minutes. All golfers must report to the golf course one half hour before the first tee time.

Fees: \$40.00 application Fee. \$50.00/golfer at Darlington, Orchard Hills, Overpeck and Rockleigh; \$60.00/golfer at Valley Brook, includes greens fee and cart fee and is due 14 days prior to event. The group is responsible for the fee associated with the number of tee times reserved, regardless of the number of golfers that play. The Application Fee is a non-refundable donation to the Pioneer Junior Golf Program.

Food: Food is available at each course. Special arrangements can be made upon request. **Alcoholic Beverages are not permitted.**

Rules and Regulations: Group Golf participants are subject to all Bergen County golf course regulations. Any violation of these rules will constitute grounds for revocation of the group golf permit.

Dress Code: Proper golf attire includes; collared shirts, slacks or mid-length shorts and skirts. Clothing items not appropriate for the golf course include but are not limited to: tank tops, fishnet shirts, short shorts or short skirts, sweat pants, baseball pants, spandex or bike shorts, and jeans with holes. Golf shoes and sneakers are the only acceptable shoe permitted for play. Metal spikes are not permitted. This policy applies to both male and female golfers.
