May be done thru the mail or in person at any golf course.

If renewing by mail, send the following items:

- ___ Completed form
- ___ **Original** golf ID card*
- ___ Copy of your driver's license**
- ___ Stamped self-addressed envelope
- ___ Check payment (Make check payable to Bergen County Department of Parks)

If your age category has changed from last year, you must renew in person to have a new card printed.

*If you have lost your golf card, you must renew in person and there will be an additional \$10 replacement card fee.

If renewing in person, bring the following to any golf course:

- ___ Completed form
- ___ Driver's License with photo**
- ___ Golf ID card*
- ___ Cash or credit card payment (Visa or MC)

NEW REGISTRATIONS:

Must be done in person. Bring the following items to any golf course:

- ___ Completed form
- ___ Driver's License**
- ___ Cash or credit card payment (Visa or MC)

In lieu of driver's license must provide **two of the following documents with name and address listed: Current Deed to Residence, Current Lease to Residence, Current Residential Property Tax Bill, Current Utility Bill or Current W-2 or 1099 Statement **and** photo ID.

**Juniors need copy of birth certificate & school ID, report card or library card and parent must show driver's license.

RESIDENT DISABILITY REGISTRATIONS: A Disabled Golf ID card with discounted greens fee is available if resident has been declared 100% disabled and is currently receiving full disability benefits from Social Security. A Social Security Awards letter is required to qualify. New disability registrations can only be issued at the Golf Office. Previously issued disability registrations may be renewed at the golf courses. **A registration fee applies and is based on resident age category.**
