**Juniors need to show copy of birth certificate and must also provide school ID, report card or library card and parent must provide driver's license to verify residency. Junior golfers must play with an adult golfer aged 18 or older until the Junior golfer is 15 years old.

***If you have lost your golf card you must RENEW IN PERSON and there will be an additional \$25 replacement card fee.**

**Current Active US Armed Forces ID required.

**Military Veteran Status ID required.

RESIDENT DISABILITY REGISTRATIONS: A Disabled Golf ID card with discounted greens fees is available if Resident has been declared 100% disabled and is currently receiving full disability benefits from Social Security. A Social Security Awards letter is required to qualify. Previously issued disability registrations may be renewed at the golf courses. New disability registrations are only issued at the golf course with the required documentation and approval by golf course manager. **A registration fee applies and is based on resident age category.**
