RESIDENT DISABILITY REGISTRATIONS: A Disabled Golf ID card with discounted greens fees is available if Resident has been declared 100% disabled and is currently receiving full disability benefits from Social Security. A Social Security Awards letter is required to qualify. Previously issued disability registrations may be renewed at the golf courses. <u>New disability registrations are only issued at the golf course with the required documentation and approval by golf course manager</u>. A registration fee applies and is based on resident age category.
